WATER SEWER SERVICE CHARGES

Res. 20-10 EFFECTIVE 05/16/2020

Water: As permitted in Ordinance No. 56, as amended, the following water service and commodity charges shall be in effect for the Rockford water system.

- a. **Water Service Charge** – A monthly service charge shall be based upon an equivalent meter basis of the water meter at premises.

- b. **Water Commodity Charge** – In addition to the service charge set forth above, each premise shall pay a commodity charge of \$4.18 for each thousand gallons of water used.

SEWER: Res. 20-11 EFFECTIVE 05/16/2020

As permitted in Ordinance No. 57 as amended, the following sewer service and commodity charges shall be effective for the Rockford sewer system:

- a. **Sewer Service Charge** – A monthly service charge shall be based upon an equivalent meter basis of the water meter at a premise.

- b. **Sewer Commodity Charge** - In addition to the Service Charge set forth above, each premise shall pay a commodity charge of \$4.18 or each thousand gallons of water used.
- c. During the period May 15 through September 15 commodity charge shall be base on 90% of water used by residential customers, but excluding customers with sprinkling meters.
- d. **Sewer Service Charge** – In addition to the service charge set forth above, each premise shall pay a monthly Waste Water Treatment Plant charge based upon an equivalent meter basis of the water meter at premises to cover the cost of designing and building a new facility to treat the North Kent Sewer Authority sewerage.

If a violation occurs, which results in the permit being revoked, a new permit must be obtained and new fees paid.

No review fees will be charged for permit extensions, but inspection fees will be charged.

Additional fees will be charged for inspections due to non-compliance and when regular inspections exceed the number paid for.
